BETWEEN

AND

Chennai Institute of Technology here in after referred to as "CIT", is an Educational Institution located at Sarathy Nagar, Kundrathur, Chennai-6000069, Tamilnadu, India, Established by Parthasarathy Seeniammal Educational Trust which is registered under Societies Act, approved by AICTE.

have agreed as follows.

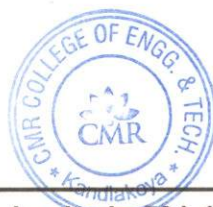
ARTICLE 1: PURPOSE OF THE MEMORANDUM OF ASSOCIATION

- 1.1 The purpose of this memorandum of Association is to facilitate broadly Institute-Institute Interaction of CMRCET with CIT.

ARTICLE 2: (A) ROLE OF CMRCET

- 2.1 CMRCET shall identify suitable Engineering and Management Students to visit CIT for Study Tours, Internships and training Programs for better Employment opportunities.
- 2.2 CMRCET shall offer consultancy services to in Association with CIT in problem areas.
- 2.3 CMRCET conducts certificate program/s for students of CMRCET under a joint certificate program with CIT.
- 2.4 CMRCET conducts training programs to Faculty or Students of CIT in the selected areas as per mutual agreement.
- 2.5 CMRCET will conduct necessary training programs in theory and labs which will be followed by on the job training to the students for their employment in industries. But this will not bind over on CIT to absorb them.
- 2.6 CMRCET provides the testing facilities and library facilities available to CIT.
- 2.7 CMRCET provides expertise in R&D and Consultancy to CIT.

- 2.8. CMRCET from time to time will approach CIT for joint Research Programs of Government of India, DST, AICTE, DRDO and other Government agencies or Organizations of Public and Private to share common facilities and expertise from time to time.

(B) ROLE OF CIT

- 2.9. CIT shall facilitate the engagement of Institute-Institute Interaction.
- 2.10. CIT shall facilitate Institute Visits / Study tours, Internships and Training for better employment opportunities for CMRCET students.
- 2.11. CIT shall facilitate Institute Visits / Study tours, Internships for Technical staff and Faculty.
- 2.12. CIT shall facilitate to share their problematic areas where CMRCET has the strong capability to do consultancy.
- 2.13. CIT shall facilitate joint certificate program.
- 2.14. CIT can avail the expertise and laboratories of CMRCET for training of their students, Technical staff and Faculty.
- 2.15. CIT can take advantage of Library, Testing facilities available with CMRCET and also avail R&D and Consulting activities with the expertise of CMRCET.

Article 3: General Terms, Restrictions and Limitations.

- 3.1 **Nature of the Memorandum of Association:** This Memorandum of Association is formulated as a statement of interest and intent to facilitate and develop mutually beneficial cooperative activities.
- 3.2 **Independent Contractor Status of the Parties:** In the performance of this memorandum of Association, both CIT and CMRCET shall be considered independent bodies. Neither of them is authorized or empowered to act as an agent for the other for any purpose. Neither of them shall enter into any contract, warranty or representation as to any matter on behalf of the other. Neither shall be bound by the acts or conduct of the other.
- 3.3 **No Warranty:** No warranties, representations or condition, express or implied, including, without limitation, any representations, warranties or conditions of accuracy or sufficiency are made by either party under this Memorandum of Association.

ARTICLE 4: VALIDITY OF THE MEMORANDUM OF ASSOCIATION

- 4.1 This Memorandum of Association is valid till 30th June 2021 from the date of this MoA notwithstanding the date of execution covers all activities undertake from the commencement of this MoA and after which the parties may mutually agree to extend

the Memorandum of Association. This Memorandum of Association may be modified or changed every year on mutually agreed terms.

In addition, by written consent of both sides, it can be modified or changed at any time. Either party shall have the right to terminate this Memorandum of Association, or any statement of work, without any cause by giving the other party minimum notice of 30 days. Notwithstanding such termination, any Program that commenced prior to such termination shall continue to the end of the normal term of the Program.

- 4.2 This Memorandum of Association has been validated by the responsible authorized signatories of CIT and CMRCET and is recorded in two original documents.
