NOW THIS MEMORANDUM OF UDNERSTANDING WITNESSE AND IT IS HEREBY AGREED AND CONFIRMED BY AND BETWEEN THE TWO PARTIES HERETO AS FOLLOWS:

#### ARTICLE 1: PURPOSE OF THE MEMORANDUM OF UNDERSTANDING

1.1 The purpose of this memorandum of understanding is to record the mutual understanding between YGK and CMRCET basis which they agreed to collaborate in successfullyhelping the STUDY ABROAD aspirants by training the students for GRE, TOEFL/IELTS and Admission Counseling services for Study Abroad.

## ARTICLE 2: ROLES AND RESPONSIBILITIES OF CMRCET& YGK

- (A) ROLE OF CMRCET:
- 2.1 CMRCET will mobilize the students for the proposed Training program.

- **2.6** YGK will assess the candidates in advance and monitor their progress during the training period
- **2.7** YGK will provide resource persons from the industry to serve the students on above mentioned services.

- 2.8 YGK will conduct periodic assessments for all the students at regular intervals
- **2.9** YGK will provide material, GRE class companion & Supplement book which covers necessary content for in-class training, GRE Official Guide and also an online portal that has 5 full-length simulative tests and 20 timed drills. Apart from these, timely soft copies (having around 800 to 1000 questions on each module) for practice are sent to the students after every class.
- **2.10** YGK will identify a single individual who will act as the YGK Academy representative with regard to the program and will be the single point of contact for YGK Academy.

#### **ARTICLE 3: PROGRAMMES ADMINISTRATION**

YGK will undertake the execution and administration of the program, with the active support of CMRCET. Periodic meetings may be conducted between the representatives of CMRCET and YGK to assess the progress of the programs.

## ARTICLE 4: MUTUAL OBLIGATIONS BETWEEN THE PARTIES

- **4.1** YGK is allowed to display its promotional material viz., Display Boards, Posters etc. in the college boards etc.
- **4.2** YGK is empowered to use the program to replicate in other places. This MOU does not prohibit YGK to enter similar MOUs with any other entities.
- **4.3** Intellectual Property Rights (IPR) for the material developed and shared by YGK are with YGK Academy and is a constituent in the courseware and other material that would be used in conducting the programs.

**4.4** CMRCET shall depute coordinators to mentor enrolled students', In addition to the resource persons from YGK to conduct referred programs at CMRCET.

## ARTICLE 5: GENERAL TERMS, RESTRICTIONS AND LIMITATIONS

- **5.1 Nature of the Memorandum of Understanding:** This Memorandum of Understanding is formulated as a statement of interest and intent to facilitate and develop mutually beneficial cooperative activities.
- **5.2** Independent Contractor Status of the Parties: Both the parties to the MOU shall be considered independent contractors. Neither of them is authorized to act as an agent to each other.

#### ARTICLE 6: VALIDITY OF THE MOU

- **6.1** This MOU is valid for a period of one year from the date of execution of this MOU. This MOU may be modified or changed by written consent of both the parties. Any party shall have the right to terminate this MOU, or any statement of work, without any cause by giving the other party a prior written, acknowledged notice of 90 days. Notwithstanding such termination, any training program that commenced prior to such termination shall continue to the end of the normal term of the training program.
- **6.2** This MOU has been validated by the responsible authorized signatories of YGK and CMRCET, who have signed below, and is recorded in two original documents.
- **6.3** The parties shall try to implement this program in a spirit of co-operation. Any and all disputes or claims arising out of or relating to this MOU or any program or the breach hereof shall be endeavored to be settled by mutual discussions between the authorized representatives of both parties within a period of one month from the date of notification of any such dispute or claim in writing by one party to the other.
